Did you know that there are people living in and around Boone County who have never been to the Boone County Fair? It's quite possible that these same people may not be aware of you and your business. We of the Boone County Fair Board can help both of us and improve these situations.

## **NEW LOWER PRICE THIS YEAR FOR INDOOR BOOTHS!**

We have advertising space available for you to use to showcase your business and products. We have 9 x 9 spaces (or multiples thereof) with electrical outlets available **inside** for \$60 per space. We also have 12 x 12 spaces available **outside** under the awning on the south side of the Community Building for \$25. Both of these options require a \$50 deposit to make sure that the booth is in tact for the duration of the fair. The hours for Commercial Exhibits are Thursday- Sunday July 17-20 from 11:00am to 8:00 pm. You may set up inside on Wednesday July 16<sup>th</sup> after 7:00 pm or Thursday July 17<sup>th</sup> before 11:00am. We have had many suggestions for getting more patrons to the fairgrounds and especially into the Commercial Exhibits building. Therefore, we will be changing locations on some of the booths this year.

We also have outside 20 x 30 spaces available for \$60. They are located south and west of the Community Building. For Boone County residents, there is no charge.

All applications and fees are due to the office by May 1<sup>st</sup>, 2008.
